

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.upliftingability.com and Uplifting Ability, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Uplifting Ability, LLC include www.upliftingability.com, Mommy UpliftHER United, www.mommyuplifterunited.com and www.tiffaniborders.com. The Uplifting Ability, LLC website is a membership, information, ecommerce and blog site. By using the Uplifting Ability, LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Uplifting Ability, LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

Uplifting Ability, LLC does not sell, rent or lease its customer lists to third parties.

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party.
